20 On May 8, 2012, David A. Gill, the permanent receiver (the "Receiver")
21 appointed in the above-captioned case, filed his *Motion for Order Authorizing*
22 *Receiver to Sell Rockwall Holdings Common Stock Free and Clear of Liens and*
23 *Other Interests, with Liens and Other Interests to Attach to Sale Proceeds, and for*
24 *Related Relief* (the "Motion") (docket entry no. 117). By way of the Motion the
25 Receiver sought authority to, among other things, sell 10,150,926 shares of common
26 stock of Rockwall Holdings, Inc., a Nevada corporation ("Rockwall"), to Triple Win
27 Partnership, LLC, Series 1, a Delaware limited liability company ("Triple Win"), for
28 \$203,018.52. The Receiver has been advised by Triple Win that it does not wish to

1 proceed with the proposed transaction. Accordingly, the Receiver hereby withdraws
2 the Motion without prejudice.
