22 On December 13, 2018, the Court heard and considered the following requests
23 for approval of professional fees and expenses on an interim basis (collectively the
24 “Requests”):

- 25 1. Fourth Interim Application of David A. Gill, Receiver, for Approval of
26 Professional Fees and Expenses (*docket no. 249*); and
27 2. Fourth Application of Danning, Gill, Diamond & Kollitz, LLP, for
28 Approval of Professional Fees and Expenses (*docket no. 250*).

1 The Honorable Andrew J. Guilford, United States District Court Judge,
2 presided at the hearing. Appearances were as noted on the record at the hearing.

3 The Court having considered the Requests, having heard the statements of the
4 Receiver and counsel at the hearing, for good cause appearing, it is

5 **ORDERED THAT:**

6 1. The Requests are approved.

7 2. The fees and expenses of David A. Gill, Receiver (the "Receiver"), for
8 services rendered from May 1, 2015, through October 31, 2018, are allowed, on an
9 interim basis, in the amounts of \$30,649.50 and \$478.57, respectively. The Receiver
10 is authorized to pay such amounts at this time, on an interim basis.

11 3. The fees and expenses of Danning, Gill, Diamond & Kollitz, LLP
12 ("DGDK"), for services rendered from May 1, 2015, through October 31, 2018, are
13 allowed, on an interim basis, in the amounts of \$133,042.50 and \$2,049.88,
14 respectively. The Receiver is authorized to pay such amounts at this time, on an
15 interim basis.

16 4. The Receiver is authorized to pay DGDK, on an interim basis, fees
17 previously allowed on an interim basis, but not yet paid, pursuant to orders entered
18 on June 5, 2012 (*docket no. 121*), February 26, 2014 (*docket no. 174*), and October
19 14, 2015 (*docket no. 214*).

20 5. If the Receiver's cash on hand is insufficient to pay the above allowed
21 amounts in full, the Receiver is authorized to pay allowed expenses in full, and then
22 is authorized to pay allowed fees on a *pro rata* basis.
