26 made by persons appearing at the hearing, for good cause appearing, it is


27 **ORDERED THAT:**

- 28 1. The Application is approved.

1           2.     The fees and expenses of Crowe Horwath LLP (“Crowe”), for services  
2 rendered from July 21, 2015, through October 31, 2018, are allowed, on an interim  
3 basis, in the amounts of \$453,185.00 and \$735.86, respectively. The Receiver is  
4 authorized to pay such amounts at this time, on an interim basis.

5           3.     If the Receiver’s cash on hand is insufficient to pay the above allowed  
6 amounts in full, the Receiver is authorized to pay allowed expenses in full, and then  
7 is authorized to pay allowed fees on a *pro rata* basis with other professionals.
